PLAN 58M-21213 PTS 1 TO 7 AND 9 TO 20



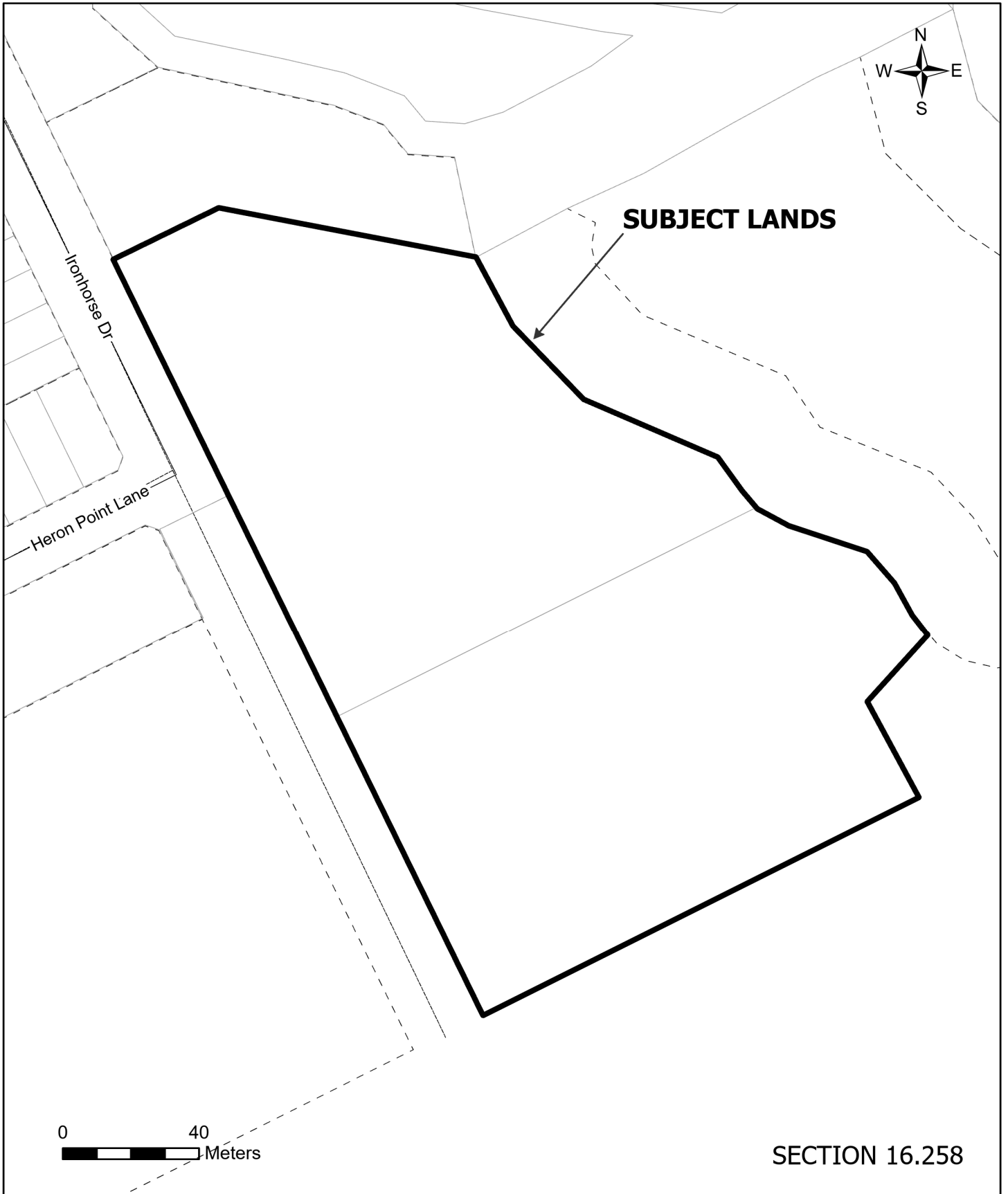

PLAN 58M407 BLK 60

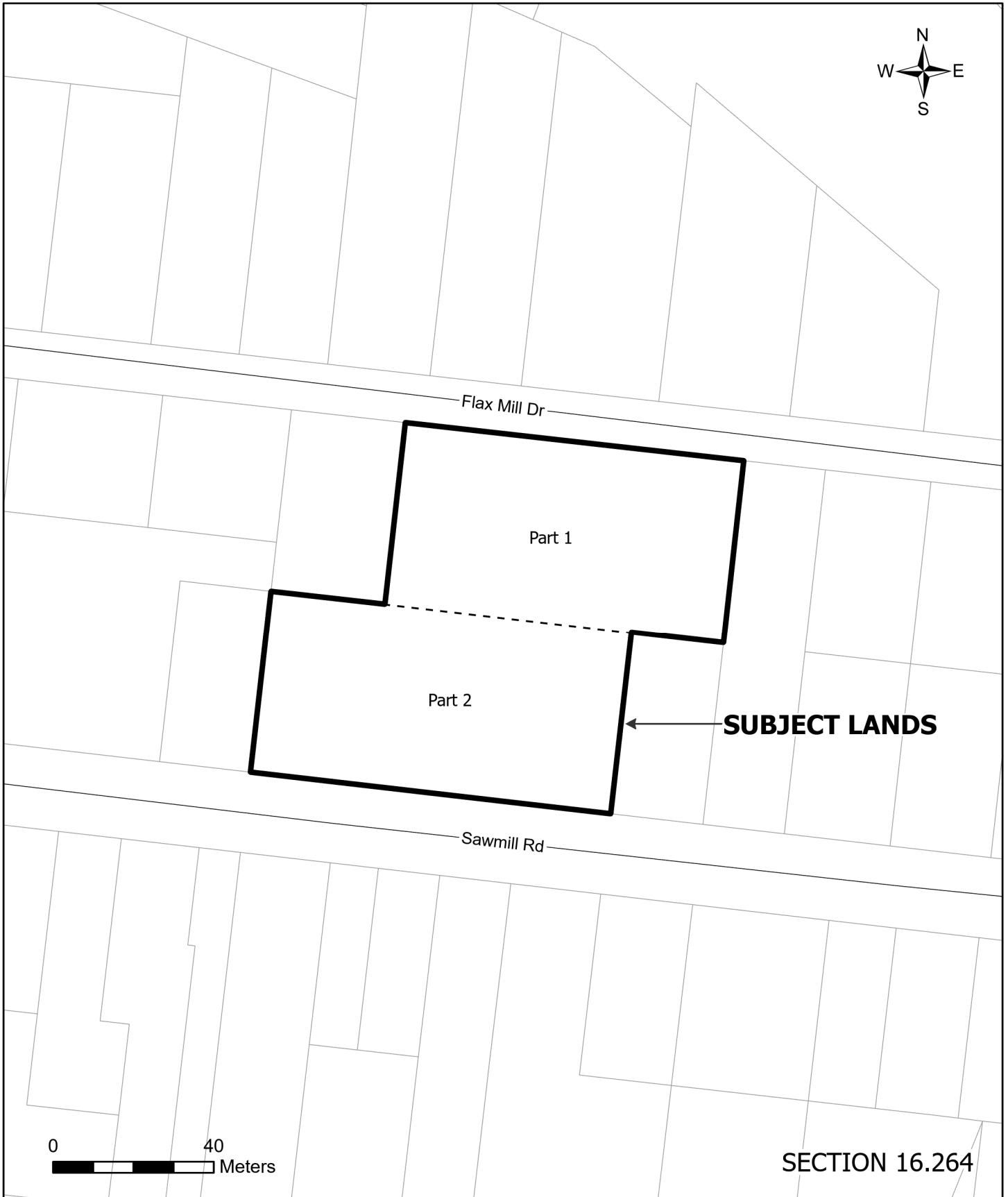
