The Woolwich North Distribution System is a stand-alone and is not treated by the Township of Woolwich, therefore, there is no chlorine boosting, ultraviolet (UV) irradiation, secondary disinfection, and pressure boosting or pressure control within the control of the water distribution system. The Township of Woolwich does not own or operate the water storage facilities servicing this system.

The Woolwich North distribution system receives water from the Waterloo Well Supply, which is part of the Urban Integrated System. The Urban Integrated System is owned and operated by the Regional Municipality of Waterloo.

The Township of Woolwich owns and operates the Woolwich North Distribution System, including pipes, valves, and residential meters. The Woolwich North distribution system services a population of approximately 15106 people with about 5088 residential service connections, with approximately 583 hydrants

Water treatment is the responsibility of the Region of Waterloo. The Region of Waterloo reports all the treatment chemicals used via their annual Water Quality Reports for the Integrated Urban System.
