TRACT CROOKS C BROKEN FRONT EGR PT LOT 4 TOG WITH ROW



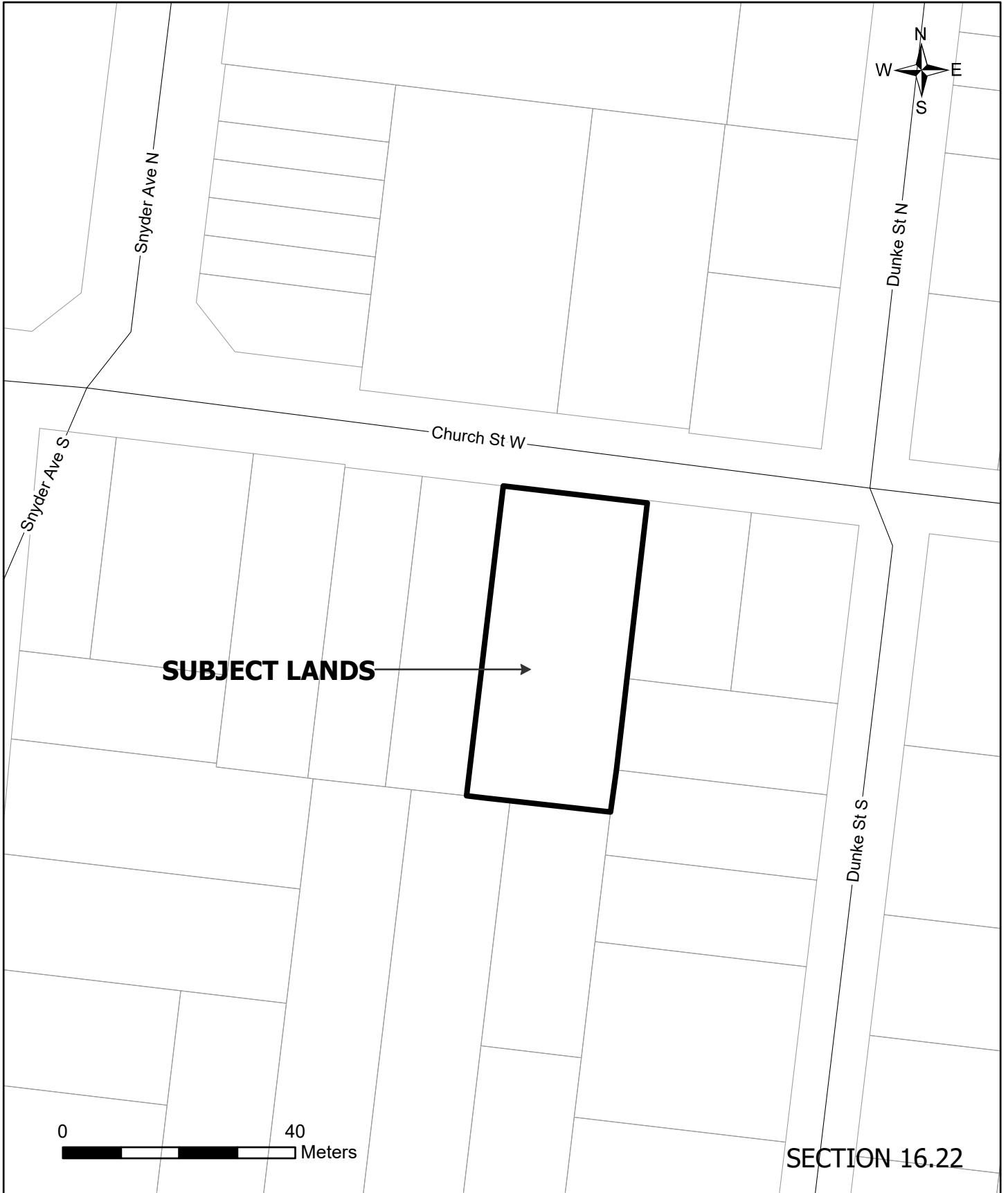

REG COMP PLAN 1364 PT LOTS 5 9 & 10



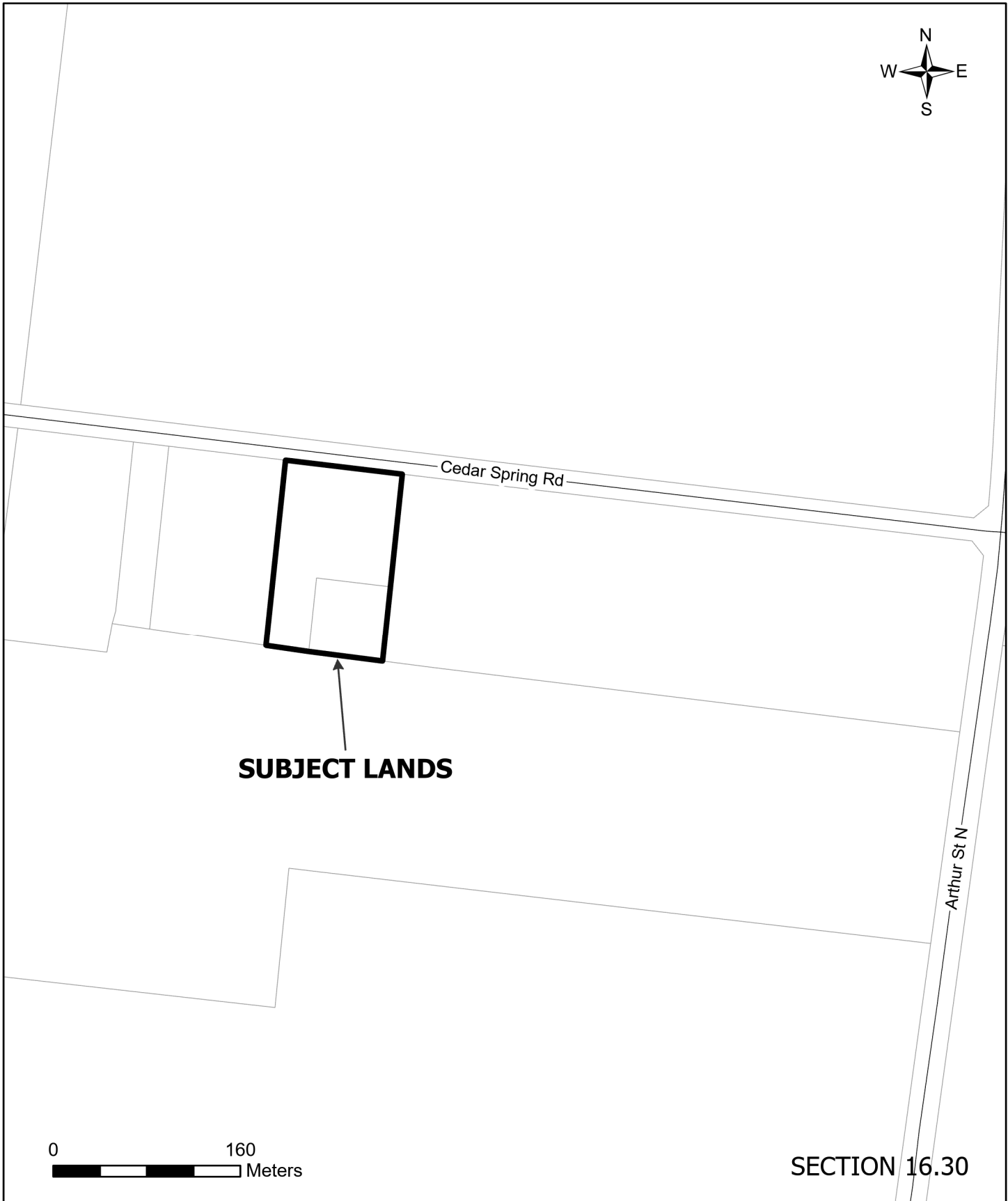
